The **Cercle** brings together, in an informal, restricted and private setting, eminent personalities from the world of business and politics who are associated in an elitist and privileged manner to the activities offered by the **WDA World Diplomatic Academy** and the **Crans Montana Forum**.

*The **Cercle** is a permanent tool for meetings, exchanges, consolidation of networks, penetration of new markets and deepening of individual contacts.*

The **Cercle** provides its Members with unique synergies enabling them to:

- **make the most of what each event** offers in terms of relational potential. Indeed, the superposition over two to three days of an impressive number of activities and personalities does not always allow a coherent organization of schedules
- benefit from **permanent and high-level support** to **maintain, nurture and deepen personal contacts and synergies**
- benefit from solutions allowing them to develop and reinforce their visibility, both personal and professional, in frameworks adapted to the strategic needs of their communication and their development.

THE CERCLE FOUNDING MEMBERS

The “**Founding Members**” of the **Cercle** are exceptional personalities from the public, governmental or business sectors associated by the Organization, in the most efficient way. They are involved in and support the activities of the **Cercle**, in particular through their initiatives.

The “**Founding Members**” of the **Cercle** have a permanent access to the Presidency of the Organisation in order to get support and advice in their professional endeavors.

They enjoy the same privileges than the **Associates Members** but, in addition, they are welcome to

- suggest and sponsor their specific activities or events
- join prestigious activities they may propose to the Organisation

ASSOCIATE MEMBERS OF THE CERCLE



Associate Members of the **Cercle** are chosen and admitted by decision of the Council of the **WDA World Diplomatic Academy**, chaired by **HRH Prince Jean of Luxembourg**.

Associate Members are, in general, natural persons. If a legal person is admitted, it then appoints a natural person Representative who will be the sole interlocutor of the Cercle, will take part in the events and will benefit from the privileges offered.

The number of Associate Members is limited in order to maintain the very high level and elitist nature of the framework.

ASSOCIATE MEMBERS' PRIVILEGES

The **Cercle** Associate Members enjoy on a yearly basis:

1. permanent access to the activities of the **WDA World Diplomatic Academy**, its **Think Tank** and the **Crans Montana Forum** (no registration fee and attribution of "Platinum" status)
2. a personal invitation to all statutory dinners and diplomatic activities when organized by the **Cercle des Ambassadeurs à Paris**
3. The **Cercle** Associate Members enjoy, within the framework of the **WDA World Diplomatic Academy** and the **Crans Montana Forum** events throughout the world:
 - a special status granting them a prestigious visibility
 - the possibility of intervening in an advisory capacity in the preparation of events and Programs, by suggesting axes and topics of interest for their activities
 - the possibility of proposing the invitation of personalities from the political, governmental or business world
 - the possibility of proposing and sponsoring the organization of specific events
 - exceptional contact facilities by being invited to private meetings (meetings, breakfasts, lunches, dinners, etc.) bringing together exceptional personalities
 - within the framework of a prior agreement, personalized assistance throughout the year for the organization of their contacts during their travels and meetings
 - personal invitations to exceptional and exclusive events reserved for them

FINANCIAL CONTRIBUTION

Associate Members of LE CERCLE pay an annual fee.

Founding Members pay a one-time, flat-rate contribution, entitling them to the privileges mentioned without time limit.
